What is this product and what will it do?

The soil in your yard may not be able to give your plants the iron and other elements they need to be beautiful, green, and hardy. If the leaves on your plants look washed out, yellow (chlorotic), or mottled, use CHELATED IRON PLUS to green them up fast. CHELATED IRON PLUS provides nitrogen, potassium and phosphorus to give plants a gentle boost. It also contains chelated iron, manganese and zinc, elements necessary for successful plant growth. For best results, apply as a foliar spray for quick response and as a soil drench to build up a supply of these necessary elements.

USE PRECAUTION: Keep this product off sidewalks, patios, driveways, etc. This product contains iron for plant nutrition which will stain concrete and painted surfaces.

How do I use this product?

Mix CHELATED IRON PLUS with the recommended amount of water and use a sprinkling can or hose-end sprayer to wet the plant foliage and drench the soil. For best results soil should be moist before applying fertilizer solution.

To apply as a foliar spray: Spray foliage thoroughly; wet both sides of leaves and allow spray to drip from leaves.

To apply as a soil drench: Apply to thoroughly saturate root areas, using 1/2 to 2 gallons of diluted mixture per plant depending on size of plant, root areas to be treated, or size of container.

Lawns and Turf: Apply at the rate of 6 fl. oz. in 5 gallons of water per 1,000 sq. ft. (50'x 20') of lawn. The contents of this container will cover 5,333 sq. ft. Repeat at 2 to 3 week intervals as needed. When used as directed, this product provides 0.01 pounds of nitrogen per 1,000 sq. ft. of lawn per application. Use this product as a supplement to your normal lawn fertilization program. Typical lawns will use from 1 to 4 pounds of nitrogen per 1,000 sq. ft. per growing season.

Ornamental and Evergreen Shrubs (roses, rhododendrons, azaleas, camellias, gardenias, holly, juniper, pine, arborvitae and many others) & Ornamental and Shade Trees: Use 2 tablespoons per gallon of water. Apply as a foliar spray or soil drench. Repeat every 14 days throughout the growing season.

Flowers & Bedding Plants (such as annual and perennial flowers, hanging baskets, bulbs, and container plants indoors and out): Use 1/2 to 1 tablespoon per gallon of water. Apply as a soil drench. Repeat every 14 days throughout the growing season. Alternate with Lilly Miller® Vita Bloom™ Liquid Bloom Fertilizer to promote budding and vibrant colorful blooms.

Groundcovers (such as ivy, iceplant, gazania, cotoneaster, bear berry, pachysandra and ajuga): Use 1 tablespoon per gallon of water. Apply as a foliar spray or soil drench. Repeat every 14 days throughout the growing season.

Citrus & Avocados, Fruits & Vegetables: Use 2 tablespoons per gallon of water. Apply as a foliar spray or soil drench. Repeat every 14 days throughout the growing season.

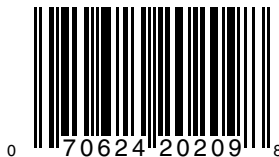
